AMENDMENT TO ARTICLES OF INCORPORATION

WE, the undersigned, James DeMordaunt, President, and Alice DeMordaunt, Secretary, of D & D ENTERPRISES, INC., an Idaho corporation, do hereby certify:

That as of August <u>18</u>, 1987, the following amendments to the Articles of Incorporation of D & D ENTERPRISES, INC., was consented to and authorized by the unanimous written consent of the holders of all of the issued and outstanding stock of said corporation entitled to vote, in accordance with the provisions of Section 30-146(5) of the Idaho Code.

RESOLVED, that the Articles of Incorporation of D & D ENTERPRISES, INC., be amended as follows:

Article IV of the original Articles of Incorporation shall be repealed, and the following Article shall be adopted to replace said Article IV:

"ARTICLE IV

The principal place of business, registered office, and location and post office address of the registered office of said corporation shall be 345 Shoshone Avenue, Rexburg, Idaho 83440, and the mailing address of said corporation shall be P.O. Box 5, Rexburg, Idaho 83440."

Article VI of the original Articles of Incorporation shall be repealed, and the following Article shall be adopted to replace said Article VI.

"ARTICLE VI.

The number of directors of said corporation shall be not less than two (2) to be elected annually."
