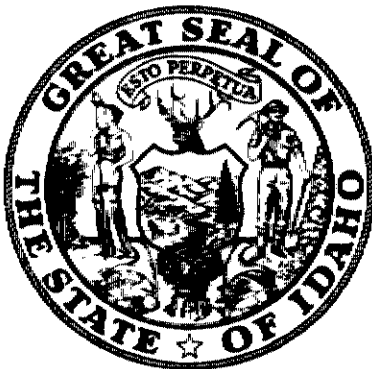

ARTICLES OF INCORPORATION  
OF  
UNIVERSITY CHRISTIAN CHURCH OF CHRIST, INC.

KNOW ALL MEN BY THESE PRESENT, that we, the undersigned, being natural persons of full age, all of whom are citizens of the United States or its territories or possessions, have this day voluntarily associated themselves for the purposes of forming a private non-profit corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

ARTICLE I

CORPORATE NAME

That the name of this corporation shall be UNIVERSITY CHRISTIAN CHURCH OF CHRIST, INC.

ARTICLE II

CORPORATE EXISTENCE

That the period of existence and duration of life of this corporation shall be perpetual.

ARTICLE III

NON-PROFIT CORPORATION

This corporation is to be a non-profit corporation under the laws of the State of Idaho.

#### ARTICLE IV

##### REGISTERED OFFICE AND INITIAL REGISTERED AGENT

The location of the registered office of this corporation shall be in Moscow, Latah County, Idaho, and the mailing address shall be 924 South Jefferson, Moscow, Idaho. The initial Registered Agent of the corporation shall be Craig Benjamin.

#### ARTICLE V

##### CORPORATE PURPOSE

1. The purposes for which this corporation is organized are to assist the members in worship of the Lord; to facilitate the orderly transactions of the Lord's business to conduct activities that promote worship, fellowship and Christian love.

2. To undertake and carry on any business transactions or operations necessary or desirable for the accomplishment of the purposes hereinabove set forth, and to do all other things incidental thereto or connected therewith, which are not forbidden by Idaho law, or other law, or by these Articles in Incorporation.

3. This corporation is a church, and the management of its affairs is to be vested in its members pursuant to Section 30-314-C, Idaho Code except to the extent that it is set forth in the church officers pursuant to the By-Laws of the corporation.
