The undersigned, Grand Master Borkman; Grand Recorder, and Trustees of the Grand Lodge of Ancient Order United Workmen, of Washington, an order without capital stock, organized and carried on solely for the mutual benefit of its members and their beneficiaries and not for profit, and having a lodge system with ritualistic form of work, and representative form of government, desiring to bring said order in closer relation to the general insurance laws of the State of Washington, as defined in Title XLV, Article VII, of Remington's Compiled Statutes of Washington, 1922, do, by direction of the Grand Lodge, execute and file the following;

AMENDED ARTICLES OF INCORPORATION:

I.

The corporate name shall be "GRAND LODGE OF ANCIENT ORDER UNITED WORKSEN, OF MASHINGTON."

II.

The principal place of business shall be at the City of Seattle, King County, Washington.

III.

The objects and powers of the Grand Lodge of Ancient Order United Workmen, of Washington shall be -

(a) To unite white male and female persons, over the age of sixteen years and under the age of fifty-five years, in social and fraternal brotherhood; membership shall be social or beneficial at the option of the member, but no person shall be admitted to beneficial membership who has not passed a satisfactory medical examination, and no person over the age of fifty-five years shall be admitted to beneficial

membership in any lodge of the order except to transfer from some other lodge subordinate to this Grand Lodge.

- (b) To organize, continue and establish subordinate lodges of Ancient Order United Norkmen in the State of Washington, said subordinate lodges, including those already organized and subordinate to the Grand Lodge of Ancient Order United Norkmen, of Washington, shall be subject to such laws, rules and regulations as may be enacted by the Grand Lodge of Ancient Order United Norkmen, of Washington at its stated or special Grand Lodge meetings.
- (c) To create, hold, invest and disburse the funds and transact the business of the order, under the constitution, laws, rules and regulations now in force, or which may hereafter be enacted by the Grand Lodge, and as provided by the laws of the State of Tashington, and all rules and regulations promulgated by competent authority in pursuance thereof.
- according to plan of insurance and form of certificate, and from time to time to levy upon and collect from the members of each such class, monthly rates or assessments sufficient to mature the beneficiary certificates of the order and to pay death losses according to the form of certificate, such assessments to be exclusive of Grand Lodge dues and general expense fund. No part of any fund so raised by assessments or monthly rates, and to be known as "the beneficiary fund" shall ever be used for any purpose other than the payment of the amounts due the beneficiaries of the deceased members

of the lodges subordinate to the Grand Lodge of Ancient Order United Workmen, of Washington, in the class for which it is accumulated, and any surplus that may arise from monthly assessments or rates, after raying all matured death losses, shall be set aside as an emergency fund to be used for the same purposes only, and only when the regular monthly rates or assessments are insufficient to pay matured death claims; and no member shall acquire or create an individual interest or claim in such emergency fund.

- under existing certificates heretofore issued by the Order in the manner now or hereafter to be adopted by the Grand Lodge and as from time to time provided in the Constitution and laws of the Order; to issue certificates after the following forms of insurance: "The level life" plan; the "term" plan; the "annuity" plan; the "Ten-year payment" plan; the "Fifteen-year payment plan; and the "Twenty-year payment" plan, and such other plan or plans of insurance as may be hereafter adopted by the Grand Lodge of Ancient Order United Workmen, of Washington, in accordance with the laws of the State of Washington, and all rules and regulations promulgated in accordance thorewith.
- (g) The rates to be charged for fraternal insurance, shall be according to the plan or plans now or hereafter to be adopted by the Grand Lodge and filed with and approved by the State Insurance Commissioner.
- (h) To sue and be sued by its corporate name; to have and use a corporate seal, which it may alter at pleasure.
 - (i) To purchase or otherwise acquire lands for

corporate purposes, and to receive and hold by gift and devise, real and personal property and to sell and dispose of the same in the ordinary course of its business.

IV.

The Grand Lodge is composed of the Past Grand Master Workman, Grand Master Workman, Grand Foreman, Grand Overseer, Grand Recorder, Grand Treasurer, Grand Inside Watchman, Grand Medical Examiner, Members of the Grand Lodge Committee on Finance, Members of the Grand Lodge Committee on Laws, and Representatives from the several subordinate lodges under the jurisdiction of this Grand Lodge, and five Grand Lodge Trustees. The membership of the Grand Lodge may be increased or diminished, or changed, at any regular session of the Grand Lodge by a two-thirds vote of the representative members present at such session.

V.

The regular sessions of this Grand Lodge shall be held at such place in the State of Washington as it shall provide at its last preceding session; the next session to be held on the second Wednesday of April, in 1925, and bi-ennially thereafter.

VI.

All contracts or other instruments shall be executed on behalf of, and in the name of, the Grand Lodge of Ancient Order United Workmen, of Washington, by the Grand Master Workman, attested by the Grand Recorder, under the corporate seal.

When the Grand Lodge is not in session, its business and the business of the corporation shall be managed and conducted by the Grand Officers, Trustees and Standing Committees of the Grand Lodge exercising such functions and powers as are prescribed in the constitution and laws of the Order.

AMENDED ARTICLES OF INCORPORATION OF GRAND LODGE OF ANCIERT ORDER UTITED FORWARD OF WASHINGTON

KNOW ALL MEN BY THESE PRESENTS: That the Grand Lodge of Ancient Order United Workmen of Washington, for the purpose of amending its articles of incorporation and amendments thereto with respect to time of meeting, objects and powers, its composition and officers, as appears more fully herein, hereby makes its amended articles of incorporation as follows, to wit:

ARTICLE I.

The corporate name of this corporation shall be Grand Lodge of Ancient Order United Workmen of Washington.

ARTICLE II.
The home office of the corporation shall be in the City of Seattle, King County, Washington.

ARTICLE III.

The Grand Lodge shall meet as often as once in four years or oftener as may from time to time be determined by the Grand Lodge. The time and place of such meeting shall be determined by the Grand Lodge when in session, or may be determined if in the judgment of the Grand Laster workson and amajority of the Trustees another time and place will bestserve the interests of the society. Special meetings may becalled by the Grand Magter Morley with the company of a majority of the Grand Master Workman with the consent of a majority of the Grand Lodge Trustees.

ARTICLE IV. The objects and powers of the corporation shall be-

- (a) To operate under a constitution and laws for its government and to carry on and conduct a fraternal benefit society under the lodge system as defined in ARTICLE VI. Title 45 of Remington's Compiled Statutes of Washington. and all acts amendatory thereof;
- (b) To continue, organize and establish subordinate lodges in the State of Washington, and in other states and territories of the United States of America, and in foreign countries, which lodges shall be subordinate to the Grand Lodge of Ancient Order United Workship of Washington, and shall be subject to its Constitution and the laws, rules and regulations of the society and such as may be enacted by the Grand Lodge at any regular or special meeting;
- (c) To continue, and to establish from time to time, plans of insurance and to collect from members monthly rates or premiums for the purpose of paying death losses and such withdrawal values as its laws may allow, and to change, alter, or as end, such plans and rates from time to time when necessary or needed to fulfill and perform the obligations of the society to its members:
- (d) To sue and be sued in its corporate name; and to have and use a corporate seal, and alter the same at pleasure;

- (e) To purchase, receive by gift, accept by devise, or otherwise acquire real and personal property, or the use thereof, and to sell or dispose of the same in the ordinary course of business;
- (f) To do any and all things permitted or required by the laws of the State of Washington, and more particularly by the Insurance Code thereof; the powers and limitations thereof being adopted by reference as fully as if written herein.

ARTICLE V.

The Grand Lodge is composed of the following: All Past Grand Master Workman in good standing; Grand Master Workman; Grand Foreman; Grand Overseer; Grand Recorder; Grand Treasurer; Grand Guide; Grand Inside Watchman; Grand Outside Watchman; Grand Medical Examiner; hembers of the Grand Lodge Committee on Finance; Mashers of the Grand Lodge Committee on Laws; five Grand Lodge Trustees, and qualified representatives from the several subordinate lodges under the jurisdiction of the Grand Lodge; Provided, that the elective members shall constitute a majority in the number and have not less than two-thirds of the votes in Grand Lodge, nor less than the votes required to amend or change the Constitution and Laws of the Society.

ARTICLE VI.

All contracts of the Grand Lodge and all instruments by and on behalf of the society shall be executed on behalf of and in the name of the Grand Lodge of Ancient Order United Workmen of Washington by the Grand Laster Workman, and attested by the Grand Recorder under the scal of the Grand Lodge.

ARTICLE VII.

The duties of the officers and members of Committees shall be as prescribed in the Constitution and Laws of the society. The business of the Grand Lodge between sessions of the Grand Lodge shall be managed by the Grand Master Workman, the Committee on Finance, the Committee on Laws and the Grand Lodge Trustees, as provided in the Constitution and Laws of the society. All officers of the Grand Lodge, other than the members of the Committee on Finance, the Committee on Laws, the Grand Recorder and the Grand Treasurer, shall be elected by the Grand Lodge. The Lembers of the Committee on Finance and the Committee on Laws shall be appointed by the Grand Master Workman, and the Grand Recorder and Grand Treasurer shall be appointed from time to time by the Grand Lodge Trustees, all as provided in the Constitution and Laws of the society.

AMENDED ARTICLES OF INCORPORATION OF GRAND LODGE OF ANCIENT ORDER OF UNITED WORKMEN OF WASHINGTON and CHANGING NAME TO ANCIENT ORDER UNITED WORKMEN

KNOW ALL MEN BY THESE PRESENTS: That the Grand Lodge of Ancient Order United Workmen of Washington, for the purpose of amending its Articles of Incorporation and embracing as amendments thereto changes from time to time made in the Constitution and Laws of the Order as appears more fully herein, hereby makes its Amended Articles of Incorporation as follows, to-wit:

ARTICLE I.

The corporate name of this corporation shall be Ancient Order United Workmen.

ARTICLE II.

The home office of the corporation shall be in the City of Seattle, King County, Washington.

ARTICLE III.

The supreme governing body of the corporation shall be its Grand Lodge; the corporation shall meet in Grand Lodge as often as once in four years or oftener as may from time to time be determined by the Grand Lodge when in session or may be determined if in the judgment of the Grand Master Workman and a majority of the Trustees another time and place will best serve the interest of the society. Special meetings may be called by the Grand Master Workman with the consent of the majority of the Grand Trustees.

ARTICLE IV.

The objects and powers of the corporation shall be -

- (a) To operate under a constitution and laws for its government and to carry on and conduct a fraternal benefit society under the Lodge system as defined in Chapter 48.36 Revised Code of Washington and all acts and amendments thereto;
- (b) To continue, organize and establish subordinate lodges in the State of Washington and other states and territories of the United States of America and in foreign countries, which lodges shall be subordinate to the Grand Lodge and shall be subject to its constitution and laws, rules and regulations of the society and such as may be enacted by the Grand Lodge at any regular or special meeting;
- (c) To continue and to establish from time to time plans of insurance and to collect from members monthly rates of premiums for the purpose of paying death losses and such withdrawal values as its laws may allow, and to change, alter, or amend such plans and rates from time to time when necessary or needed to fulfill and perform the obligations of the society to its members;

(d) To sue and be sued in its corporate name and to have and use a corporate seal, and alter the same at pleasure;

(e) To purchase, receive by gift, or accept by devise, or otherwise acquire real and personal property or the use thereof and to sell or dispose of the same in the ordinary course of business;

(f) To do any and all things permitted or required by the laws of the State of Washington and more particularly by the Insurance Code thereof; the powers and limitations thereof being adopted by reference as fully as if written herein.

ARTICLE V.

The Grand Lodge is composed of the following:

All Past Grand Master Workmen in good standing, Grand Master, Grand Foreman, Grand Overseer, Grand Recorder, Grand Treasurer, Grand Guide, Grand Inside Watchman, Grand Outside Watchman, Grand Medical Examiner; Members of Grand Lodge Committee of Finance, Members of Grand Lodge Committee, Members of Grand Lodge Fraternal Committee, Members of Grand Lodge Executive Committee, five Grand Lodge Trustees, and qualified representatives from the several subordinate lodges under the jurisdiction of the Grand Lodge; provided that the elective members shall constitute a majority of the number and have not less than two-thirds of the votes in Grand Lodge nor less than the votes required to amend or change the Consitution and Laws of the society.

ARTICLE VI.

All contracts of the corporation and all instruments by and on behalf of the society shall be executed on behalf of and in the name of Ancient Order United Workmen by the Grand Master Workman and attested by the Grand Recorder under the seal of the corporation.

ARTICLE VII.

The duties of the officers and members of committees shall be as prescribed by the Constitution and Laws of the society. The business of the corporation between sessions of the Grand Lodge shall be managed by the Grand Master. Workman, the Grand Trustees and the several Grand Lodge committees as provided in the Constitution and Laws of the society. 

ARTICLES OF INCORPORATION

I.

The Corporate name shall be, Grand Lodge of Ancient Order United Workmen of Washington.

II.

The principal place of business shall be at the City of Seattle, King County, Washington.

III.

The objects and powers of the said Grand Lodge of the Ancient Order United Workmen of Washington shall be,

- (a) To unite unite white male persons in a Fraternal Brotherhood; provided that no person shall be admitted to membership who has not passed a satisfactory medical examination and who is not a citizen of the State of Washington; and provided further, that no person under the age of 18 years or over the age of 45 years shall be admitted to membership in any lodge of the Order, except by transfer from some other lodge subordinate to this Grand Lodge.
- (b) Mo organize, continue and establish subordinate lodges of the Ancient Order United Workmen in the State of Washington. Said subordinate lodges, including those already organized and subordinate to the Grand

Lodge of the Ancient Order United Workmen, shall be subject to such laws, rules and regulations as may be enacted by the Grand Lodge of the Ancient Order United Workmen of Washington at its stated meetings hereinafter provided for.

- (c) To create, hold and invest and disburse the funds, and transact the business named in these Articles, under the constitution, laws, rules and regulations now in force, or that may hereafter be enacted by the Grand Lodge.
- (d) To pledge the Grand Lodge to the payment of a stipulated sum (never to exceed two-hhndsand dollars) to such beneficiary as the deceased member may have designated while living, under such restrictions and upon such conditions as the laws of the order may prescribe.
- (e) To levy upon and collect from the members monthly rates or assessments for the purpose of paying death losses, which assessments or monthly rates shall continue to be those used at the present time and not be less than the following classified rates, viz:-

exclusive of lodge dues and General expense fund. These rates are on what is known as the Step Rate Plan and advance with the advanced age of the member, and the right is reserved for the creating of two or more additional classes over the age of fifty at an increased rate if such should be deemed necessary by the organization, and provided that no partnof the fund so raised by said assessments or monthly rates and to be known as the Beneficiary Fund, shall be used for any purpose other than the payment of the amounts due the beneficiaries of the deceased members of the lodges subordinate to the Grand Lodge of the Ancient Order United Workmen of Washington; and provided that any surplus that might arise from the monthly assessments or rates after paying all matured death losses shall be set aside as an Emergency Fund to be used for the same

ments are insufficient to pay matured death claims, and no member shall acquire or create an <u>incidivual</u> interest or claim in such Emergency Fund; and provided further, that should Ancient Order United Workmen Organizations in other states or jurisdictions, from any cause whatever require financial assistance in the payment of their death losses, this Grand Lodge may, by a two-thirds vote of the legislative members present at the Session of said Grand Lodge, vote to extend a Fraternal Aid contribution to be paid to the Supreme Lodge of the Ancient Order United Workmen, or the Grand Lodge of the Ancient Order United Workmen of some other jurisdiction out of the Emergency Fund, such Fraternal aid contributions to continue and be in force only so long as the begislative members in the Grand Lodge assembled may determine, and shall not create any liability on the part of the Grand Lodge jurisdiction of the Ancient Order United Workmen of Washington.

- ment plan in conjunction with the classified plan now in force, on all new members and on all old members passing a satisfactory medical examination and who may desire such rate, such rates to remain level through life, to be paid in monthly rates and assessments, and not to be less than \$.85 per month for age eighteen, per thousand dollars of protection, and an increased rate for every age admitted above that of eighteen years of age and the money collected in this way to be in every way governed by the same rules as those established under the classified rate of assessment now used by the prder.
- (g) To sue and be sued by its corporate name; to have and use a corporate seal which it may alter at pleasure.
- (h) To purchase and hold, and receive by gift and devise, real and personal property, and to sell or dispose of the same in the ordinary course of its business.

IV.

The Grand Lodge is composed of the Past Grand Master Workman, Grand

Master Workman, Grand Foreman, Grand Foreman, Grand Overseer, Grand Receiver, Grand Inside Watchman, Grand Medical Examiner, Supreme Representatives, Members of the Grand Lodge, Committee on Finance, Members of the Grand Lodge committee on laws, and Representatives from the several subordinate lodges under the jurisdiction of tis Grand Lodge, and fove Grand Lodge trustees; provided that the membership of the Grand Lodge may be increased or diminished or changed at any regular session of the Grand Lodge by a two-thirds vote of the legislative members present at such session.

٧.

The regular sessions of this Grand Lodge, shall be held at such place in the state of Washington, as it shall provide at its last preceding Session; said Session to be held Annually, on the Second Wednesday of April; provided, tha Grand Lodge may, at any regular Session, by a two-thirds vote of its legislative members present, change the date of its Annual Sessions, or may provide for Biennial Sessions of the Grand Lodge, by the same required vote.

All contracts of this Grand Lodge, and all instruments by and on behalf of this Corporation, shall be executed on behalf of and in the name of the Grand Lodge of Ancient Order of United Workmen of Washington by the Grand Master Workman, attested by the Grand Recorder, and under the seal of the Grand Lodge, and when so executed and attested shall be binding upon the Grand Lodge, and Corporation.

VI.

The business of the Grand Lodge and of the Copporation, between sessions of the Grand Lodge, shall be managed by the Grand Master Workman Grand Recorder, Grand Receiver, Grand Lodge Committee on Finance, Grand Lodge Committee on Laws, and five trustees; all of whom shall be elected at the regular sessions of the Grand Lodge, except the members of the two Grand Lodge Committees, who shall be appointed by the Grand Master Workman, as provided in the General Laws of the Order, and shall exercise only such powers and authority as are enumerated in the Constitution and

By-Laws of the Order.

VII.

The Executive Officers and Trustees to serve until the next regular session of the Grand Lodge, to be held on the Second Wednesday in April, 1907, are E. Steinbach, Grand Master Workman; L. M. Simms, Grand Foreman; A. M. Baldwin, Grand Overseer; J. H. Hemer, Grand Recorder; John Spedding, Grand Receiver, and Oliver Hall, C. W. Hunt, H. C. Comegys, W. S. Banner and Louis J. Hart, Trustees.
