- 1. <u>Name</u>. The name of the corporation is buzzWords, Inc. (the "Corporation").
- 2. <u>Authorized shares</u>. The aggregate number of shares the Corporation is authorized to issue shall be five million (5,000,000), all of which shall be common voting stock. There shall be only one class of stock authorized.
