The undersigned, acting as incorporators of U.S. VEND-TURE, INC., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:
