

CERTIFICATE OF AMENDMENT

Adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware

WE, RAYBURN L. FOSTER, Vice President and R. E. ARNOLD, Assistant Secretary of Phillips Petroleum Company, a corporation existing under the laws of the State of Delaware, do hereby certify under the seal of the said corporation as follows:

1. That Article FOURTH of the Certificate of Incorporation of Phillips
Petroleum Company has been amended to read as follows:

"FOURTH: The total number of shares authorized to be issued by this corporation is Fifty Million (50,000,000), all of which shall be common stock having a par value of Five Dollars (\$5) a share.

The corporation will commence business with a minimum amount of One Thousand Dollars (\$1,000)."

2. That such amendment has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
