The undersigned, acting as incorporators of a nonprofit corporation in accordance with the provisions of the Idaho Nonprofit Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article I**

The name of the corporation shall be "Lewiston Rural Fire Service, Incorporated."

**Article II**

Lewiston Rural Fire Service, Incorporated, shall be a nonprofit corporation in conformity with the provisions of the Idaho Nonprofit Corporation Act.

**Article III**

Lewiston Rural Fire Service, Incorporated, shall be a nonprofit corporation perpetual in its duration.

**Article IV**

Lewiston Rural Fire Service, Incorporated, is organized for the purpose of making fire protection service available to the unincorporated areas of rural Nez Perce County, Idaho.

**Article V**

The registered office of Lewiston Rural Fire Service, Incorporated, shall be:

## Article VI

The board of directors of Lewiston Rural Fire Service, Incorporated, shall be made up of three (3) directors. The directors on the initial board of directors are:

The term of each director shall be one (1) year, and successor directors shall be elected by the existing directors.


