## ARTICLES OF INCORPORATION OF INTERNATIONAL DIATOM CORPORATION

Mr. Ron McKague, being over the age of twenty-one (21) years of age and a citizen of the United States of America, for the purpose of forming a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation:

#### ARTICLE I

The name of this corporation shall be INTERNATIONAL DIATOM CORPORATION.

#### ARTICLE II

The duration of this corporation shall be perpetual.

#### ARTICLE III

The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### ARTICLE IV

This corporation shall have the authority to issue one hundred thousand (100,000) shares of capital stock of the par value of twenty five dollars (\$25.00) per share. There shall be no other class or shares of stock in this corporation.

#### ARTICLE V

The owners of shares of this corporation shall not be entitled to preemptive rights to subscribe for or purchase any part of new or additional issues of stock or securities convertible into stock of any class whatsoever whether now or hereafter authorized, and whether issued for cash, property, services, by way of dividends, or otherwise.

#### ARTICLE VI

The board of directors shall have full power to adopt, alter, amend, or repeal the bylaws or adopt new bylaws. Nothing herein shall deny the concurrent power of the shareholders to adopt, alter, amend, or repeal the bylaws.

#### ARTICLE VII

This corporation reserves the right to amend, alter, change, or repeal any provisions contained in its articles of incorporation in any manner now or hereafter prescribed or permitted by statute. All rights of shareholders of this corporation are granted subject to this reservation.
