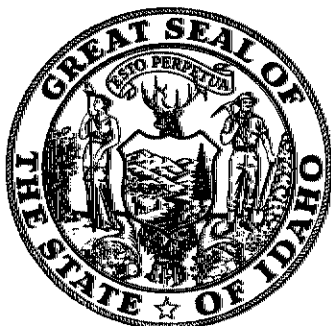

4. It hereby surrenders its authority to transact business in said state.

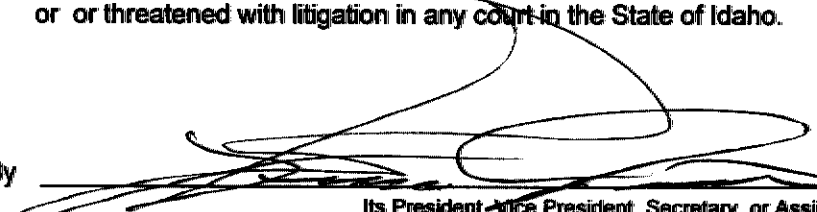
