The undersigned acting as incorporator of a corporation under the Idaho Business Corporation Act adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation shall be Ironwood on Hayden Homeowners Association, Inc.

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The purpose of this corporation is to engage in the management of the Homeowners Association and to enforce the Conditions, Covenants and Restrictions that are recorded and run with the lots which comprise Ironwood on Hayden.

ARTICLE IV.

The total number of certificates shall be twenty-three which is the exact number of lots located in Ironwood on Hayden, a subdivision in Kootenai County Idaho.

ARTICLE V.

The number of directors of this corporation shall not be less than one nor more than five.


