
CERTIFICATE OF INCORPORATION OF

The undersigned duly licensed individual authorized to render legal services within this state, desiring to form a professional corporation in accordance with Idaho Code sections 30-1301 through 30-1315 for the practice of law, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the corporation shall be **WILLIAM L. HERRINGTON, P.A.**

ARTICLE TWO PURPOSES

The purposes for which the corporation is organized are as follows:

- (1) To engage in the business of the practice of law as a professional corporation;
- (2) To engage generally in the business of a law corporation as the same is now and hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;
- (3) To engage in such other business as may be authorized or permitted by Idaho Code section 30-1307.

ARTICLE THREE PRINCIPAL OFFICE AND AGENT

The Place in the State of Idaho where the corporation's principal and registered office is to be located is 410 S. Jefferson, City of Moscow, Latah County. The registered agent shall be William L. Herrington.

ARTICLE FOUR DIRECTORS

The number of directors of the corporation shall be one (1), which number may be increased pursuant to the bylaws of the corporation. The initial director shall be William L. Herrington, of 410 S. Jefferson, Moscow, Idaho 83843.

ARTICLE FIVE STOCK


The total number of shares of stock which the corporation has authority to issue is one hundred (100) shares, which shall not be divided into classes; all of such shares are without par value. The issuance and transfer of such shares shall be subject to the restrictions and limitations of Idaho Code sections 30-1308 through 30-1315.

ARTICLE SIX DURATION

The duration of the corporation shall be perpetual.
