ARTICLES OF INCORPORATION

of

SCHREIBER CONSULTANTS, INC.

We, the undersigned, being three (3) natural persons of full age, all of whom are citizens of the United States, have this day voluntarily associated ourselves for the purposes of forming a private corporation under and pursuant to the Statutes and Laws of the State of Idaho and hereby adopt the following Articles of Incorporation:

I.

The name of the proposed corporation is:

SCHREIBER CONSULTANTS, INC.

II.

The duration of this corporation shall be perpetual.

III.

The location and post office address of the registered office of the corporation in the State of Idaho shall be:

Schreiber Consultants, Inc.

IV.

The purposes of this corporation shall be:

ARTICLES OF INCORPORATION

- A. To have and exercise all of those corporate powers as are granted by virtue of 30-1-4 Idaho Code. In addition thereto, and without limitation thereon, such corporation shall be authorized and empowered to design, test, construct, operate, manage and render consultation to all types of hydraulic works, and water works of every kind, nature and description; to contract for the rendition of consulting services including engineering services therewith.
- B. Pursuant to 30-1-6 Idaho Code, to purchase, acquire and own stock in this corporation or other corporations.
- C. To buy, own, contract for and sell, real and personal properties including the development thereof as authorized by law; to contract with municipal, public and governmental agencies for the purposes of rendering consultations, engineering, or other related services; to contract with persons, companies, partnerships or associations in association, joint venture or otherwise, for the performances of engineering and consulting services.

V.

The capital of this corporation shall be represented solely by non-assessable common stock, all of which stock shall have full voting rights in conformity with the Statutes of the State of Idaho. The total number of par value shares of stock shall be 25; the aggregate par value of the total authorized number of par value shares is \$25,000.00. The total authorized number of shares shall have

a par value of \$1,000.00 per share.

VI.

The corporation, by and through it's officers and directors, shall, pursuant to the provisions of 30-1-23(a) Idaho Code, have the power to enter into such contracts and agreements in respect to the restrictions upon transfer of stock issued by this corporation.

VII.

The corporation particularly disclaims that any shareholder of stock in this corporation shall have any pre-emptive rights to stock to be issued by the corporation as provided by 30-1-26, Idaho Code.

VIII.

The Board of Directors of the corporation, pursuant to the provision of 30-1-27 Idaho Code, shall have the right to adopt By-Laws of this corporation and shall, by a two-thirds (2/3) majority vote of the Directors, have the right to amend, repeal, and modify the By-Laws of the corporation, subject to the shareholders rights as proclaimed by 30-1-27 Idaho Code.
