ARTICLES OF INCORPORATION AM 9 00

OF

EXPEDITION EDUCATIONAL FOUNDATION, INC.

The undersigned, acting as the Incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. <u>NAME</u>. The name of the corporation is EXPEDITION EDUCATIONAL FOUNDATION, INC..
- 2. <u>NONPROFIT CORPORATION</u>. The corporation is a nonprofit corporation organized and operating under the Idaho Nonprofit Corporation Act, Section 30-301 <u>et seg</u>., Idaho Code.
- 3. <u>DURATION</u>. The period of its duration is perpetual.
- 4. <u>PURPOSES AND POWERS</u>. The corporation is organized to qualify as a tax exempt organization pursuant to the requirements of Section 501(c)(3), Internal Revenue Code, as amended, and shall be operated exclusively to advance and further the following public educational and charitable goals through worldwide expeditions and explorations:
- a. Increase public understanding of the cultures and societies of other nations and countries and promote public awareness of the problems and issues confronting such cultures; and
- b. Increase public understanding of the world environment and the effect of on-going climatic changes on its future.

The corporation shall have all of the powers granted non-profit corporations under the laws of the State of Idaho. However, notwithstanding anything herein to the contrary, the corporation shall exercise only such powers as are in furtherance of the tax exempt purposes of organizations set forth in Section 501(c)(3), Internal Revenue Code, as amended.

ARTICLES OF INCORPORATION - 1

- 5. <u>MEMBERSHIP</u>. The corporation shall have one (1) class of membership. The initial members of the corporation shall be those persons designated below to serve as the initial board of directors of the corporation. A person must actively support the goals and purposes of the corporation and be nominated by vote of a majority of the existing members to qualify as a member of the corporation.
- 6. <u>REGISTERED AGENT AND OFFICE</u>. The street and mailing addresses of the initial registered office of the corporation are 120 East Avenue, Ketchum, Idaho, and P. O. Box 987, Ketchum, Idaho, 83340 respectively, and the name of its initial registered agent at such addresses is James P. Speck.
- 7. <u>INITIAL BOARD OF DIRECTORS</u>. The number of directors constituting the initial Board of Directors of the corporation is three (3). The names and mailing addresses of the persons who are to serve as directors until the first annual meeting of the members, or until their successors are elected and shall qualify, are:

- 8. <u>DISSOLUTION</u>. In the event of the dissolution or other termination of the corporation, no member shall be entitled to or receive any benefit from any distribution or division of its remaining property or other assets or its proceeds, and the balance of all money and other assets and property held or received by the corporation from any source, after the payment of all of its debts and obligations, shall be used or distributed at the direction of the members of the corporation exclusively for purposes within the requirements of Section 501(c)(3), Internal Revenue Code, as amended.
