ARTICLES OF INCORPORATION

OF

LAO ASSOCIATION OF IDAHO, [L.A.I.], INC.

The undersigned, acting as incorporator of a non-process corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for this non-profit corporation:

Ι.

The name of this non-profit corporation shall be LAO ASSOCIATION OF IDAHO, Incorporated.

II.

The period of existence and duration of the life of this non-profit corporation shall be perpetual.

III.

The address of the initial registered office of this non-profit corporation is 2616 Malad Street, Boise, Idaho, 83705, and the name of the initial registered agent at such address is Chanh Senethavilay.

IV.

The nature of the business and the object and purpose of this non-profit corporation shall be as follows:

 To provide assistance and moral and material support to all needy LAO individuals or groups in their drive for self-sufficiency;

- 2. To set up a body of elected representatives duly empowered to deal effectively and articulately with public, local, private, state or federal organizations;
- To foster and perpetuate the LAO cultural heritage;
- 4. To promote good understanding and friendship between the LAO community and the American people and others;
- 5. To set up a rallying and contact point between LAO and Idaho, in other states of the union and in other parts of the world; and
- 6. To engage in any additional lawful activity which is in furtherance of the primary purpose of this corporation, and which may be added thereto by amendment.

٧.

The authorized number and qualifications of members of the corporation, the different categories of memberships, if any, for voting and other rights and privileges of members, and their liability to dues assessments and the method of collection thereof, shall be as set forth in the By-Laws.

The first Board of Directors shall consist of five (5) directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the By-Laws; provided, however, that the number of directors constituting a Board shall not be less than three (3) nor more than seven (7).

The members of this non-profit corporation shall not be personally liable for the debts, liabilities or obligations of this non-profit corporation.

In dissolution of the corporation, after adequately providing for the debts and obligations of the corporation, any remaining assets shall be distributed to a non-profit fund, foundation or corporation.
