**ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation for the Corporation.

**ARTICLE I.  
NAME**

The name of the Corporation is GOLD HILL COMMUNITY UNION SUNDAY SCHOOL, INC.

**ARTICLE II.  
NONPROFIT STATUS**

The Corporation is a nonprofit corporation.

**ARTICLE III.  
PERIOD OF DURATION**

The period of duration of the Corporation is perpetual.

**ARTICLE IV.  
INITIAL REGISTERED OFFICE AND AGENT**

The location of this Corporation is in Southwick, County of Latah, State of Idaho. The address of the initial registered office is 2750 Linden Road, Kendrick, Idaho, 83501, and the name of the initial registered agent at this address is Kent Skaar.

**ARTICLE V.  
PURPOSES**

This corporation is incorporated exclusively for religious, charitable and educational purposes. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any private individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes.

The primary purpose of the corporation is to exist as a non-profit and non-denominational Christian Assembly serving the Gold Hill-Cedar Ridge-Kendrick Community in order to: 1) Gather together to study the scriptures of the Holy Bible and the Gospels of Jesus Christ, our Lord and Savior; 2) Share in the fellowship of Christ's community; 3) Help our friends and neighbors in the surrounding Gold Hill, Cedar Ridge and Kendrick community as the opportunity permits; 4) To preserve and maintain our historic Gold Hill Church as God's House in our community, and; 5) To celebrate the continuing heritage of the over 100 years of continuing service this Congregation has provided the community in its many forms and structures.

**ARTICLE VI.  
NO MEMBERS**

The corporation shall not have any members.

**ARTICLE VII.  
BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than three (3) and no more than nine (9) individuals, each of whom, at all times, shall be a member of the corporation. The actual number of Directors shall be fixed by the Bylaws of the Corporation. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected or appointed by the existing Directors in the manner and for the term provided in the Bylaws of the Corporation.

**ARTICLE VIII.  
DISTRIBUTION ON DISSOLUTION**

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporations, distribute all assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at the be a non-profit organizations with like or similar purposes, in such manner as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the District Court of the County in which the principal place of business of the Corporation is then located, exclusively for such purposes or to such organizations, as such Court shall determine to be consistent with the purposes of the Corporation.

ARTICLE XI.  
INFORMATIONAL STATEMENT

These articles are filed to establish a corporate structure for the Idaho association known as The Gold Hill Community Union Sunday School. Gold Hill Community Union Sunday School has been an Idaho non-profit association since July 5, 1939. Due to a consideration regarding filing for exempt status for property taxes, it was believed a non-profit corporation was a more understandable control structure for exempt applications purposes and the association voted to change its structure from an association to a non-profit corporation.

By this instrument it is publically stated that all assets of the previous Gold Hill Community Union Sunday School, an Idaho association, are to be transferred by bill of sale and quit claim deeds to Gold Hill Community Union Sunday School, Inc. formed by these articles.

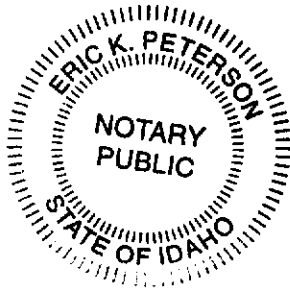
