ARTICLES OF AMENDMENT OF WARM SPRINGS GENERAL STORE, INC.

ARTICLE I

The name of this corporation is WARM SPRINGS GENERAL STORE, INC.

ARTICLE II AMENDMENTS

Article I of the Articles of Incorporation of said corporation shall be amended by deleting it in its entirety and substituting therefor the following:

"The name of this corporation is Sun Valley, Grocery, Inc."

ARTICLE III DATE OF ADOPTION

The Amendment has been approved by the Board of Directors prior to the issuance of any shares of stock of said corporation at a meeting held on the 15th day of September, 1988, at which meeting there was at all times an acting quorum of the Board of Directors.
