ARTICLES OF INCORPORATION

She if XI the undersigned, a person of the age of eighteen 12930111 0900 ness a wife to more, on behalf of the congregation of First Lutheran Church of Sandpoint do hereby adopt these Articles of Incorporation for the purpose of forming a non-profit corporation under the statutes of the State of Idaho.

ARTICLE I - NAME

The name of the corporation is FIRST LUTHERAN CHURCH OF SANDPOINT, IDAHO, INC.

ARTICLE II - NON-PROFIT CORPORATION

This shall be a non-profit, non-stock corporation, and no dividends or pecuniary profits shall be declared or paid to any member hereof.

ARTICLE III - DURATION

The duration of this corporation shall be perpetual.

ARTICLE IV - PURPOSE

The purpose of this church corporation is to participate in God's creative, redeeming and sanctifying activity in the world, and in furtherance of this purpose, the congregation as a part of the church shall:

> Worship God in proclamation of the Word and administration of the sacraments and through lives of prayer, praise, thanksgiving, witness, and service.

- b. Proclaim God's saving Gospel of justification by grace for Christ's sake through faith alone, according to the apostolic witness in the Holy Scripture, preserving and transmitting the Gospel faithfully to future generations.
- c. Carry out Christ's Great Commission by reaching out to all people to bring them to faith in Christ and by doing all ministry with a global awareness consistent with the understanding of God as Creator, Redeemer, and Sanctifier of all.
- d. Serve in response to God's love to meet human needs, caring for the sick and the aged, advocating dignity and justice for all people, working for peace and reconciliation among the nations, and standing with the poor and powerless, and committing itself to their needs.
- e. Nurture its members in the Word of God so as to grow in faith and hope and love, to see daily life as the primary setting for the exercise of their Christian calling, and to use the gifts of the Spirit for their life together and for their calling in the world.
- f. Manifest the unity given to the people of God by living together in the love of Christ and by joining with other Christians in prayer and action to express and preserve the unity which the Spirit gives.

ARTICLE V - MANAGEMENT IN THE MEMBERS

This church corporation shall have members as defined in its constitution and bylaws. Management of its affairs shall be vested in the voting members through the Congregation Meeting, and only such authority as is delegated to the Congregation Council or other organizational units in this congregation's governing documents is recognized independent of the whole congregation. All remaining authority is retained by the Congregation Meeting.

ARTICLE VI - REGISTERED OFFICE AND AGENT
