ARTICLES OF INCORPORATION OF EMERALD OIL COMPANY

WE, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the Utah Business Corporation Act, adopted the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is EMERALD OIL COMPANY.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To acquire properties for the development of oil, gas and other minerals.
- (b) To acquire and develop improved and unimproved real property.
- (c) To deal in all kinds of goods, wares and merchandise.
- (d) To have all statutory powers permitted under the provisions of the Utah Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000,000 of the par value of five cents (\$0.05).

FIFTH: The corporation will not commence business until consideration of the value of at least \$1,000.00 has been received for the issuance of shares.

SIXTH: Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: No holder of stock shall have any right, pre-emptive or otherwise, as such holder, to purchase or subscribe for or otherwise acquire shares of stock, or any securities or obligations convertible into or any right or option to purchase, any shares of stock, at any time hereafter issued or sold, but any and all such stock, obligations, rights, and options may be disposed of by the Board of Directors to

such persons, firms, corporations, and associations, and for such lawful consideration, and on such terms as the Board of Directors in its discretion may determine, without first offering the same or any thereof to the shareholders.

SEVENTH: The post office address of its initial registered office is 705 Desert Building, Salt Lake City, Utah, and the name of its initial registered agent at such address is G. W. Anderson.

EIGHTH: The number of directors constituting the initial Board of Directors of the Corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
