**PAYETTE VALLEY COOPERATIVE, INC.**

**a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the twenty-fourth day of January 1947,**

**original articles of amendment, as provided by Section 22-2009 amending Articles V (increasing capital stock from \$10,000.00 to \$50,000.00), VII and IX.**

**and that the said articles of amendment contain the statement of facts required by law, and are recorded in ~~Book~~ Film 8f Record of Domestic Corporations of the State of Idaho.**

**I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.**

CERTIFICATE OF AMENDMENT OF ARTICLES  
OF INCORPORATION OF PAYETTE VALLEY  
CO-OPERATIVE, INC.

We, Charles Pickett and C. S. Nesbitt, and each of us, do hereby certify:

That the said Charles Pickett is the President and the said C. S. Nesbitt is the Secretary of Payette Valley Co-Operative, Inc.; that Articles V, VII, and IX of the Articles of Incorporation of said Payette Valley Co-Operative, Inc. have been amended to read as follows:

ARTICLE V.

The amount of capital stock of this corporation shall be Fifty Thousand Dollars (\$50,000) and the capital shall be represented and divided into Five Thousand (5,000) shares of common stock with a par value of Ten Dollars (\$10) each. The stock shall be non-assessable.

ARTICLE VII.

Each member of this Association shall subscribe for, or own, at least five (5) shares of the capital stock of this corporation.

ARTICLE IX.

This association is formed to function on a cooperative basis for the mutual benefit of its patrons. A reasonable reserve as determined by the Board of Directors of the association not inconsistent with the laws of the State of Idaho may be set aside from year to year. After setting aside such reserve and making such deduction as may be necessary to retire loans, if any, and to pay interest on all stock held by any stockholder in excess of 5 shares, at a rate to be determined by the Board of Directors, the balance of the net earnings or savings of the association shall be distributed to the patrons on a patronage basis as determined by the Board of Directors, not inconsistent with the laws of the State of Idaho.

That said amendments were adopted as follows:

3 A special meeting of the shareholders of Payette Valley Co-Operative, Inc.  
4 was called by the President of said corporation pursuant to a resolution passed  
5 at a legally held meeting of the Board of Directors of said corporation; that  
6 prior to holding said shareholders' meeting, written notice thereof was mailed  
7 to each shareholder at his last known place of address by the secretary of  
8 said corporation more than thirty (30) days prior to the date of said meeting;

9  
10 That said notice so mailed stated the date of and place of holding said meeting,  
11 and that the purpose for which said meeting was called was to discuss the  
12 question of amending Articles V, VII, and IX in accordance with the above and  
13 foregoing amendments;

14 Each of said amendments was adopted by the affirmative vote of shareholders  
15 holding more than two-thirds (2/3) of the stock of said corporation, and that  
16 each of said amendments was voted upon separately, and each amendment was adopted  
17 by the affirmative vote of shareholders holding more than two-thirds (2/3) of  
18 the capital stock of said corporation.
