TO THE  
ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION  
OF  
ADVANCED INPUT DEVICES, INC.

The undersigned officers, on behalf of ADVANCED INPUT DEVICES, INC., a Delaware corporation authorized to do business in Idaho, do hereby execute and deliver to the Secretary of State a Certificate of Correction to the Articles of Amendment to the Articles of Incorporation of the Corporation.

1. The name of the Corporation is Advanced Input Devices, Inc.

2. Articles of Amendment to the Articles of Incorporation of Advanced Input Devices were filed with the Secretary of State of the State of Delaware on October 10, 1980, and with the Secretary of State of the State of Idaho on October 23, 1980. The Articles as thus filed were inaccurate in that they stated:

". . . One Class A common shares shall be equivalent to 100 Class B common shares."

The provision should have stated that "one Class A common shares shall be equivalent to 10 Class B common shares."

3. As corrected, Article FOURTH of the Articles of Incorporation shall read as follows:

FOURTH. The stock in the corporation shall be in two classes which shall be denominated Class A and Class B. The shares of both classes shall have no par value. The corporation shall have authority to issue 1,000 shares of Class A common stock and 19,000 Class B common stock. Class A shares and Class B shares shall be identical in all respects except that (1) Class B common shares shall not have the right to vote and (2) for purposes of conversion and determining relative rights, one Class A common share shall be equivalent to 10 Class B common shares.
