Articles of Amendment of the Articles of Incorporation of DOWN RITE INCORPORATED are herein executed by said Corporation pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

- 1. The name of the Corporation is DOWN RITE INCORPORATED.
- 2. The amendments to the Articles of Incorporation of said Corporation are as follows:

ARTICLE III shall be amended to read as follows:

"Shareholders of this Corporation shall not have preemptive rights to acquire additional shares offered for sale by the Corporation."

ARTICLE V(1) shall be amended to read as follows:

"1. The aggregate number of shares which the Corporation shall have authority to issue is one hundred thousand (100,000) shares."

A new ARTICLE VIII shall be added to read as follows:

"Shareholders of this Corporation shall not have cumulative voting rights."

- 3. The date of the adoption of said amendments by the shareholders of the Corporation is April 11, 1991.
- 4. The number of shares outstanding of Corporation is thirty-four thousand six hundred eighty-eight (34,688) shares, all of which are entitled to vote.
