## ARTICLES OF INCORPORATION

### IDAVEST, INC.

KNOW ALL MEN BY THESE PRESENTS that the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho, and the acts amendatory thereof and supplementary thereto, hereby certify as follows:

FIRST

The name of the corporation is IDAVEST, INC.

SECOND

The purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

THIRD

The corporation is to have perpetual existence.

FOURTH

The name of the registered agent and the location and post office address of the registered office of the corporation is: Sale Principles 326 N. Orchard, Boise, Idaho 83706.

FIFTH

The aggregate number of shares which the corporation shall have authority to issue shall be one hundred thousand (100,000) shares of common stock having a par value of ten dollars (\$10.00) per share. No stock shall be issued until the purchase price therefor is fully paid, and once such stock is issued, it shall be non-assessable.

SIXTH

#### SEVENTH

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatsoever and the shares of the corporation shall not be subject to assessment for the purposes of paying expenses, conducting business, or paying debts of the corporation.

The number of directors of the corporation shall be not less than three (3) nor more than seven (7). The initial board of directors shall be five (5) in number and they shall serve until the first annual meeting of the share-holders or until their successors are elected and qualified.
