

ARTICLES OF INCORPORATION

The undersigned, desirous of forming an incorporation do hereby agree and declare as follows:

1. The name of the corporation shall be Traders Mining Company Limited.

2. The purpose for which said corporation is formed is the purchase and acquisition of mines, mining claims, real estate, water rights, mill sites, tunnel sites and other easements, mining ores, milling, concentrating and reducing the same, buying and selling ore and bullion with power to conduct mercantile business, boarding houses, hotels and other adjuncts to mines and concentrating mills, and generally to do and transact mining, milling and concentrating business, with all powers incident thereto.

3. The principal place of business of this corporation shall be at Wallace, Shoshone County, State of Idaho, with power to establish branch offices elsewhere in the United States.

4. The term for which this corporation is to exist is fifty years.

5. The number of its directors shall be five. The names and residences of those appointed for the first year are as follows:


