Articles of Incorporation of the Zions Co-operative  
Mercantile and Manufacturing Institution of Oakley

Know all men by these presents that we, the undersigned, have this day, voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the Territory of Idaho, and we hereby certify that the name of said Corporation is the Zions Co-operative Mercantile and Manufacturing Institution of Oakley.

1<sup>st</sup> That the purposes for which it is formed are in the business of general merchandising & manufacturing, & dealing in the buying and selling of any personal property or real estate.

2<sup>nd</sup> That the place where its principal business is to be transacted, shall be in the town of Oakley, Cassia County, Idaho.

3<sup>rd</sup> That the term for which it is to exist is Twenty five (25) years from and after June the Twentieth (20) A. D. Eighteen hundred and Ninety (1890).

4<sup>th</sup> That the number of its Directors shall be five (5) and that the names and residences of those who are appointed for the first year are:-
