Articles of Incorporation of the Zion's Co-operative Mercantile and Manufacturing Institution of Oakley

Know all men by these presents that we, the undersigned, have this day, voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the Territory of Idaho, and we hereby certify

1st That the name of said Corporation is the Zion's Co-operative Mercantile and Manufacturing Institution of Oakley

2nd That the purposes for which it is formed are to engage in the business of general merchandising & manufacturing & buying and selling of any personal property or real estate

3rd That the place where its principal business is to be transacted, shall be in the town of Oakley, County of Cassia, Territory of Idaho.

4th That the term for which it is to exist is Twenty five (25) years from and after June the Twentieth (20) A. D. Eighteen hundred Ninety (1890).

5th That the number of its Directors shall be five (5) and that the names and residences of those who are appointed for the first year are:-
