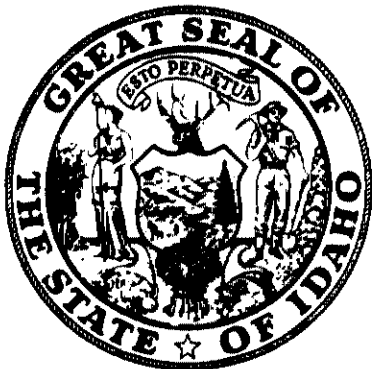

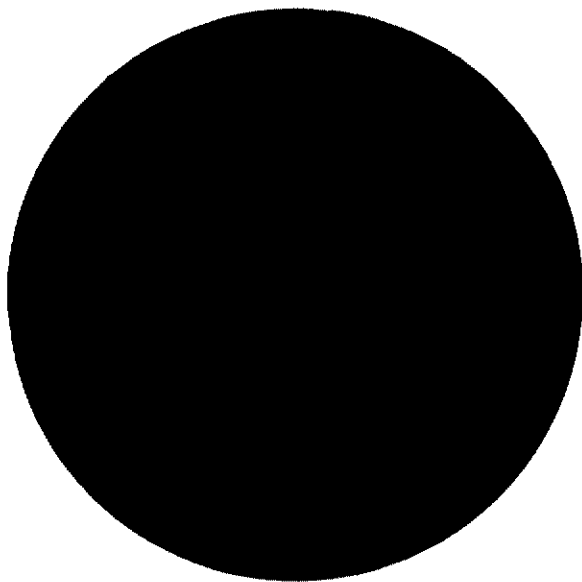
CERTIFICATE OF GOOD STANDING
