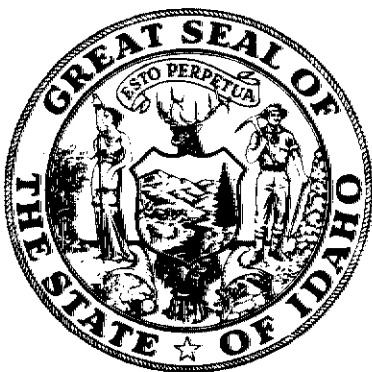

**ARTICLES OF AMENDMENT TO THE ARTICLES OF
INCORPORATION OF VIDEO BIBLE OUTREACH, INC.**

Pursuant to the provisions of Section 30-326, Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I.

The name of the corporation is VIDEO BIBLE OUTREACH, INC.

ARTICLE II.

Paragraph SECOND of the Articles of Incorporation of Video Bible Outreach, Inc., is amended to read as follows:

"SECOND: The corporation is a nonprofit corporation. It is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code."

ARTICLE III.

Paragraph FOURTH of the Articles of Incorporation of Video Bible Outreach, Inc., is amended to read as follows:

"FOURTH: The purposes for which the corporation is organized are the production and distribution of Christian religious programs and any other lawful

activities which a nonprofit religious corporation may pursue under the Idaho Nonprofit Corporation Act. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code."

ARTICLE IV.

The Amendment was adopted by a Consent in writing signed by all members entitled to vote with respect thereto.
