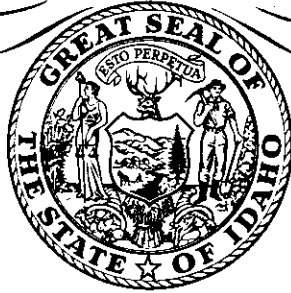

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

CHAPEL OF THE CROSS CHURCH OF MARSING, IDAHO, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Twentieth** day of **August**, 19 **64** original articles of amendment, as provided by Section s 30-146, 30-147, and 30-1103, Idaho Code, amending ARTICLE IV, purposes; ARTICLE VII, changing number of directors from Three to Four; and ARTICLE I, changing corporate name to:

ASSEMBLY OF GOD CHURCH OF MARSING, IDAHO, INC.

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **129** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF CHAPEL OF THE CROSS CHURCH OF MARSING, IDAHO, INC.

Glenn T. Faulks and Vene Foster, being each duly affirmed, on their respective oaths do depose and say as follows:

That the said Glenn T. Faulks is the duly elected and acting chairman of the board of the Chapel of the Cross Church of Marsing, Idaho, Inc., and Vene Foster is the duly elected and acting secretary-treasurer of the Chapel of the Cross Church of Marsing, Idaho, Inc.

That on the ^{1st}~~25th~~ day of ^{May}~~August~~, 19⁶⁴~~65~~, at Marsing, Idaho, the aforementioned corporation did hold a meeting for the purpose of considering changes and amendments to the Articles of Incorporation of said corporation. That at that time a quorum was present and a majority of the members constituting said quorum in attendance at the meeting did vote to amend Article I, Article IV, and Article VII of the Articles of Incorporation, That said meeting was held pursuant to Title 30, Chapter 11, of the Idaho Code and in accordance with the laws of the State of Idaho made and provided. That notice as required therein was given by publication, as required by law, and an affidavit of publication is attached hereto and marked as Exhibit "A", and is by reference thereto made a part hereof.

That the amendment is to the effect that Articles I, IV, and VII of the Articles of Incorporation of said corporation are amended so that the same do read in their entirety as follows:

"ARTICLE I.

"The name of this corporation shall be ASSEMBLY OF GOD CHURCH OF MARSING, IDAHO, INC.

"ARTICLE IV.

"The purposes for which this corporation is formed and is to be conducted and operated are as follows:

"1. To operate and maintain an Assembly of God Church in the city of Marsing, Idaho, and to promote religious worship and teach and preach the word of God; to establish and maintain a place of worship and teachings for the meeting of the church; to carry on and conduct missionary, educational and charitable work.

"2. To purchase, have, hold, lease, use and take possession of, and enjoy in fee simple or otherwise, any real or personal property necessary or incident to, or in connection with the purposes of the corporation, and to sell, lease, alien, mortgage or otherwise hypothecate such property; to borrow money for the accomplishment of any of the above enumerated purposes.

"3. The above enumerated purposes shall also be considered as a statement of powers, and this corporation may do each and every thing suitable or proper for the accomplishment or attainment of any one or more thereof, or conducive to or expedient for the interest or benefit of the corporation; in addition thereto the corporation shall have, and may exercise any other or further rights, powers and privileges granted by the law to corporations of a religious character.

"ARTICLE VII.

"The government of this corporation and the management of its affairs shall be vested in a board of four directors, to be elected by the members at the annual meeting of the corporation, as provided in the by-laws. No person shall be a director of this corporation unless he be a member of the corporation, and a regular contributor to the support of the church. Such Board shall select from their own number a President, Vice-President and Secretary-Treasurer."
