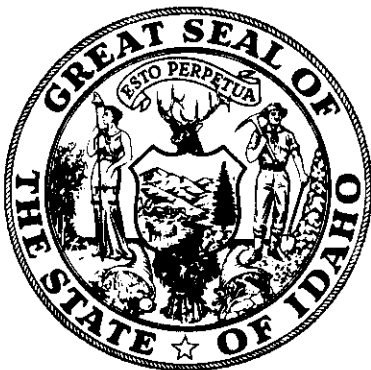

ARTICLES OF INCORPORATION

OF

LYNN INDUSTRIAL COATINGS, INC.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be LYNN INDUSTRIAL COATINGS, INC.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is formed to carry out any lawful purpose and shall have all the powers allowed by the laws of the State of Idaho.

ARTICLE IV

The capital stock of this corporation shall be in the amount of \$25,000.00, divided into 25,000 shares of non-assessable common stock of the par value of \$1.00 per share.

ARTICLE V

The principal place of business of this corporation shall be in the City of Boise, County of Ada, State of Idaho, at 512 East 45th Street, Boise, Idaho, 83704, which is hereby designated as the address of its registered office.

ARTICLE VI

The name and post office address of the incorporator is David Mark Lynn, Route 3, Eagle, Idaho 83616.

ARTICLE VII

The management of this corporation shall be vested in a board of not less than one (1) director and a maximum number as may be fixed by the By-Laws. Other than the first directors of the corporation, the directors shall be elected at the annual meeting of the stockholders to be held at a time and place designated by the By-Laws. The first directors of this corporation are:

ARTICLE VIII

The Board of Directors of this corporation by a majority vote shall have the power to repeal or amend the By-Laws thereof, and to adopt a new code of By-Laws if in their discretion that becomes proper.

ARTICLE IX

The private property of the stockholders of this corporation shall not be subject to the payment of the corporate debts in any amount or to any extent whatever.
