The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is "JD COLLISION REPAIR, INC."

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 5,000, \$1.00 par value.

ARTICLE VIII

Pursuant to Idaho Code Section 30-1-821, any action required by the Idaho Business Corporation Act to be taken at a meeting of the directors may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by all of the directors entitled to vote with respect to the subject matter thereof; such consent shall have the same effect as a unanimous vote of directors. Nothing herein shall preclude other action by the directors where no meeting is required, and in such instances no written consent shall be required.

ARTICLE IX
