ARTICLES OF INCORPORATION

OF

CLAY JACKSON ELECTRIC, INC.

The undersigned, persons of the age of more than eighteen years, acting as the incorporators of the above corporation, hereby sign and acknowledge the Articles of Incorporation in duplicate originals and do declare and set forth as follows:

ARTICLE I.

The name of the corporation shall be Clay Jackson Electric, Inc.

ARTICLE II.

The duration of the corporation shall be perpetual.

ARTICLE III.

The purposes for which the corporation is formed are:

1. The purpose or purposes for which this corporation is organized is the operation of an electrical contracting business, and any and all lawful purposes for which a corporation may be incorporated under the Idaho Business Act.

2. To carry on the primary business in which the corporation intends to initially engage; to employ any and all persons necessary for the purpose of or in connection with any aspect of the business.

3. To acquire by purchase, subscription or otherwise, and to hold for investment or otherwise, and to use, sell, assign, transfer, mortgage, pledge or otherwise deal with or dispose of stocks, bonds, or any obligations or securities of any corporation in such manner as may be provided by law.

4. To borrow money and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of all kinds, whether secure by mortgage, pledge or otherwise without limit as to amount except as may be prohibited by statute and to secure the same by mortgage, pledge or otherwise and generally to make and execute all agreements and contracts of every kind and description.

ARTICLE IV.

The authorized capital stock of this corporation shall be Fifty Thousand Dollars (\$50,000.00) consisting of fifty thousand (50,000) shares of common stock at \$1.00 par value.

ARTICLE V.

The capital stock of this corporation shall be one class only, and all shares shall have equal rights and voting powers and there shall be no preferences.

ARTICLE VI.

No shareholder shall have the preemptive right to acquire unissued share of the corporation stock.

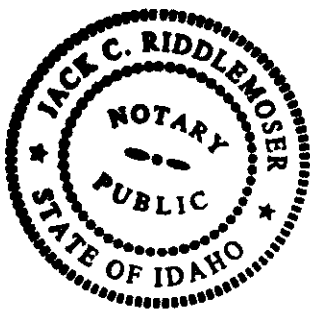
