

**Addendum to Articles of Incorporation**  
**Grace Center, Inc.**

Article 6 of the Articles of Incorporation for Grace Center, Inc. shall be the following:

The corporation is organized entirely for charitable and educational purposes, as defined in IRC 501(c)(3), or, in the event of an amendment to the IRC, whatever code section is designated as describing charitable, non-profit, and tax-exempt corporations. The corporation intends to lessen the burdens of government by providing community support by meeting the general needs of families experiencing financial difficulties, by providing healthcare counseling to improve the health of the public, and by providing counseling to address the community's mental health issues. The corporation's purpose is to provide support for the community, community members, and other community organizations through counseling, both pastoral and clinical; through a family resource operation that will try to meet families' physical needs, specifically targeting families suffering from parental and caregiver drug use; and, lastly, by providing a clinic to serve the healthcare needs of the community, whether those needs can be met with referrals, education, or direct care, as appropriate.
