NONPROFIT

KNOW ALL MEN BY THESE PRESENT; That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a nonprofit corporation for the purposes herein-after stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho, and the Acts amendatory thereof and supplemental thereto, do hereby certify as follows;

FIRST

The name of the corporation is BIBLE STUDENTS OF BOISE, INC.

SECOND

This corporation is a lawful nonprofit corporation as set forth in the "Idaho Nonprofit Corporation Act"

THIRD

The corporation is to have perpetual existence.

ARTICLES OF INCORPORATION, P. 1

FOURTH

The purpose or purposes for which the corporation is organized are;

- (a) The corporation is organized as a religious, educational organization for the promotion of Christian knowledge through the use of any and all legitimate means that may be available; to preach the Bible as the Word of God, in the spirit of tolerance and good will toward all through lectures and the printed word.
- (b) This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (c) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section (c) (3) of the Internal Revenue Code.

FIFTH

The corporation has members. The management of the affairs of the corporation are vested in the Board of Directors whose authority is limited as set forth in the corporations Bylaws.

SIXTH

Other provisions of the corporation are;

- (a) The internal affairs of the corporation are regulated by the corporations Bylaws.
- (b) Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

SEVENTH
