

I.

The name of this corporation is: IDAHO CHRISTIAN ASSOCIATION, INC.

II.

A. This corporation is a public benefit corporation and is not organized for the private gain of any person or entity. It is organized under the Nonprofit Corporation Laws of the State of Idaho, exclusively for charitable and educational public benefit purposes as specified below.

B. The specific purpose of this corporation is to operate as a religious, social and charitable organization, and to engage in any lawful activity which is permitted within the meaning of the Idaho Nonprofit Corporations Act of 1993 and any subsequent equivalents.

III.

The name and address of the initial incorporator of this corporation's incorporator is Herm Steger, 11513 West Amity Road, Boise, Idaho, 83709.

IV.

The name and address in the State of Idaho of the registered agent is: John C. Keenan, 14 12th Avenue South, Nampa, Idaho, 83651.

VII.

#### VIII.

##### OPERATION

A. This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.

C. Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income taxes under IRC Section 501(c)(3) or (b) by a corporation contributions to which are deductible under the IRC Section 170(c)(2), or corresponding provisions of any future United States internal revenue law.

##### MEMBERSHIP


This corporation is not a membership corporation and shall not have members within the meaning of the Nonprofit Corporation Laws of the State of Idaho.

X.

DISSOLUTION

The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income of the assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts, liabilities and obligations of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and shall be operated exclusively for charitable and educational purposes in harmony with those of this organization, and which has established its tax exempt status under IRC Section 501(c)(3).
