KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are natural persons of full age, citizens of the United States of America and residents of the State of Idaho, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and more particularly under Chapter 3, Title 30, Idaho Code, and to that and hereby adopt articles of incorporation as follows:

ARTICLE I.

The name of the corporation is KIWANIS CLUB OF HOMEDALE INC.
Homedale, Idaho.

ARTICLE II.

KIWANIS CLUB OF HOMEDALE INC. is a non-profit corporation.

ARTICLE III.

The purpose of the corporation is for providing community services.

ARTICLE IV.

The term for which this corporation shall exist shall be perpetual.

ARTICLE V.

The corporation has members and the management of its affairs is to be vested in its members pursuant to Section 30-314 (c), Idaho Code.

ARTICLE VI.

The address of its initial registered office is Box 973






