Article A

Specialty Chemical, Inc.

Article B

The corporation shall exist perpetually.

Article C

The purpose of this corporation shall be to engage in any or all lawful business for which corporations may be incorporated under this act.

Article D

The aggregate number of shares which the corporation shall have the authority to issue is as follows: 100 shares, no par value of common voting stock. All such common shares may be issued from time to time by the Board of Directors and any and all shares issued for the consideration fixed by the Board of Directors shall be fully paid shares and not liable to any further call or assessment thereon and the holder thereof shall not be liable for any further payment thereon.
