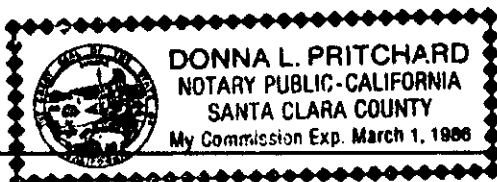

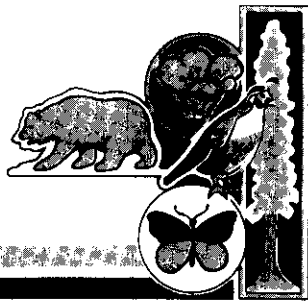

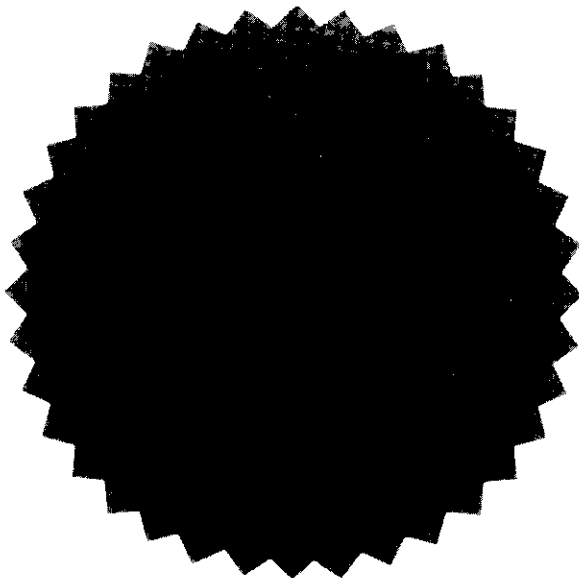

ARTICLES OF INCORPORATION

1

RANCHO DEL PINO, INCORPORATED

1

The name of this corporation is: RANCHO DEL PINO,
INCORPORATED.

II

The purposes for which this corporation is formed,
the specific business in which the corporation is primarily
engaged, being set forth in Paragraph (a) below, are:

(a) The specific business in which the corporation
is engaged to engage is ranching.

(b) To engage in any one or more business or trans-
actions which the board of directors of this corporation
may from time to time authorize or approve, whether related
or unrelated to the business described in (a) above or to
any other business then or therefore done by this corporation;

(c) To exercise any and all rights and powers which
this corporation may now or hereafter exercise;

(d) To act as principal, agent, joint venturer,
partner or in any other capacity which may be authorized
or approved by the board of directors of this corporation;

(e) To transact business in the State of California
and in any other jurisdiction of the United States of America
or elsewhere in the world.

... statement of purposes shall be contained in the statement of both purposes and powers, and the powers in each clause will, except where otherwise expressed, be in no wise limited or restricted by any other clause but shall be regarded as independent purposes and powers.

III

The county in the State of California where the principal office for the transaction of the business of this corporation is to be located is Santa Clara County.

IV

This corporation is authorized to issue only one class of shares: the total number of said shares shall be 2,000; the aggregate par value of all said shares shall be Twenty-five Thousand Dollars (\$25,000.00) and the par value of each of said shares shall be Ten Dollars (\$10.00). No distinction shall exist between the shares of this corporation or the holders thereof.

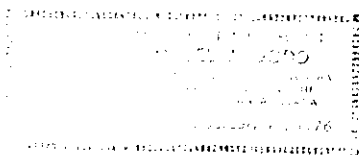
