ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF

NORTH IDAHO DAY SURGERY AND LASER SURGERY CENTER, INC.

Articles of Amendment to the Articles of Incorporation of NORTH IDAHO DAY SURGERY AND LASER SURGERY CENTER, INC. are herein executed by said Corporation pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

1. The name of the Corporation is NORTH IDAHO DAY SURGERY AND LASER SURGERY CENTER, INC..

2. The amendment to the Articles of Incorporation of said Corporation is as follows:

ARTICLE V shall be amended to read as follows:

"ARTICLE V.

1. The total number of shares authorized and which may be issued by this Corporation is one hundred thousand (100,000) shares, each with a par value of fifty cents (50¢) and all of one class to be known as common stock."

The remainder of Article V, consisting of Paragraphs 2 and 3, shall remain the same in their entirety.

3. The date of the adoption of said amendment by the shareholders of the Corporation is January 14, 1991.

4. The number of shares outstanding of Corporation was forty thousand (40,000) shares, all of which were entitled to vote.

5. The number of shares voting for and against said amendment, respectively, were as follows:

6. The amendment effectuates a two-for-one stock split, which will require shareholders to exchange their currently issued shares for twice the number of shares now held.

7. The amendment does not effect a change in the amount of stated capital of the Corporation.
