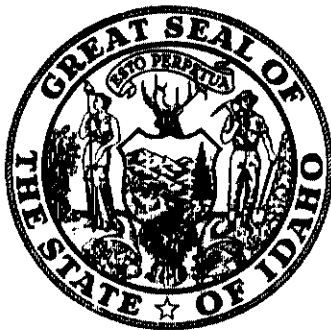
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

Snowy River Corporation

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the corporation shall be Snowy River Corporation.

ARTICLE II

The purpose for which said corporation is formed is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The corporation is to have perpetual existence.

ARTICLE IV

The capital stock of the corporation shall be one thousand (1,000) shares of common stock, without par value. The capital stock of the corporation shall not be assessable.

ARTICLE V

The address of the corporation's initial registered office is 2290 Evans, Idaho Falls, Idaho 83402 and the name of the registered agent at such address Donald MacKay III.

No director of the corporation shall be personally liable to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director except:


a. For breach of a director's duty of loyalty to the corporation or its stockholders.
