KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all of legal age, and citizens of the United States of America, over the age of Twenty-one (21) years, do, under and in pursuance of the Nonprofit Corporation laws of the State of Idaho, and particularly Title 30, Chapter 30, Idaho Code, have hereby organized, constituted and associated ourselves and such other persons as may hereafter become associated with us, for the purpose of operating a non-profit Corporation under the laws of the State of Idaho, and we do hereby adopt and certify the following **RESTATED ARTICLES OF INCORPORATION**, and we hereby set forth and declare as follows:

ARTICLE I

The name of the Corporation shall be Pregnancy Care Center, Inc.

ARTICLE II

That the location and post office address of the registered office in the State of Idaho shall be 1208 Idaho Street, Lewiston, Nez Perce County, Idaho 83501. The name and address of the registered agent is Dawn Thomas, Chairman of the Board, 1208 Idaho Street, Lewiston, Nez Perce County, Idaho 83501.

ARTICLE III

The duration and term of existence of this Corporation shall be perpetual.

ARTICLE IV

That in furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this Corporation shall have the following objects, purposes and powers:

- a) Life Choices Clinic is a Christian ministry organized exclusively for charitable, religious, educational and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, including but not limited to pregnancy consulting and related care services to the general public.
- b) Life Choices Clinic provides free pregnancy testing and limited obstetrical ultrasound imaging, along with referral services to adoption agencies, welfare agencies, Women, Infants, and Children Program, food banks, crisis centers, Idaho housing programs, and other related agencies as needed.
- c) Life Choices Clinic believes every human life is sacred as represented in the Bible and believes in preserving the sacredness of life; provides related education, including the distribution of information regarding adoption, abortion, prenatal care and child care.
- d) Life Choices Clinic distributes items to clients on a no-cost basis, including but not limited to, maternity clothing, infant and toddler clothing, diapers, cribs, car seats, high chairs, bassinets and strollers.

- e) Offers post-abortion support.
- f) Expands awareness of the dignity, the individuality, and the infinite value of every life through educational activities and Christ-centered support.
- g) Acquires, owns, hires, invests in, leases and provides facilities consisting of both real and personal property, equipment, and gear in furtherance of its powers, objects, and purposes.
- h) Life Choices Clinic has the power to do all things in connection with its objects and purposes permitted by law and to exercise any and all powers not prohibited by law as pertains to organizations of this type.

ARTICLE V

This Corporation is not organized for profit and shall have no capital stock and shall not have members, but rather shall be controlled by the board of directors as permitted by Idaho Code Section 30-30-403. To the extent the Corporation previously had members, they hereby resign upon adoption of these Articles of Restatement, pursuant to Idaho Code Section 30-30-408(1).

ARTICLE VI

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.






