## ARTICLES OF INCORPORATION

OF

## BENNETT TREE FARMS, INC.

### KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being bona fide natural born citizens of the United States of America, over the age of twenty-one years, do, under and in pursuance of the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

I.

#### NAME

The name of the corporation is BENNETT TREE FARMS, INC.

II.

#### PRINCIPAL OFFICE AND REGISTERED OFFICE IN IDAHO

The location of the principal office of the corporation in the State of Idaho is in the City of Princeton, County of Latah. Branch places of business and offices for carrying on the business of the corporation may be established at such other places as the Board of Directors may deem advisable and the business of said corporation may be carried on in any other State, States, Country or Countries. The principal place of business of the corporation may be changed by the Board of Directors of the corporation at any regular or special meeting of said Board.

#### PURPOSE

The nature of the business or purposes to be conducted or promoted

1. To engage in any lawful act or activities which corporations may be organized for under the general corporation laws of Idaho.

2. To manage all the timber lands owned by said corporation, to farm said lands to produce the highest yield of timber of all species, to investigate and conduct the research into the various problems incident to the production of timber either by natural or artificial means. The investigation of and research into the problems connected with the conversion of forests in marketable products and utilization of wood materials to the highest economic advantage together with the reduction of waste through research into new uses of such waste material customarily resulting from the conversion and manufacture of timber products. To experiment with seeds, nursery stocks and otherwise. The experimental production of suitable planting stock with specific purposes in mind of developing suitable tree species for farm wood production.

3. To buy or otherwise acquire and sell or otherwise dispose of, and in any manner deal in, with, timber, timber lands and the products of the forests, of any and all kinds, in any and all States, in any form or condition, whether felled, standing or growing. To fall said trees or have them fallen. To purchase or otherwise acquire, take on lease, sell, convey, mortgage or otherwise dispose of, and in any manner deal in and with lands, timber, logging operations, felling, hauling or otherwise transporting, cutting, working and hauling trees, logs, timber, wood, forest products, in any and all forms and for any and all purposes. To borrow or raise money for any of the purposes of the corporation and from time to time, without limit as to amount, to draw, make, accept, endorse, execute and issue promissory notes, drafts and bills of exchange, warrants, bonds, debentures and other negotiable or non-negotiable instruments and evidences of indebtedness for any of the objects or purposes of the corporation and to secure payment of any thereof and the interest thereon

or pledge conveyance or assignment in trust of the whole

or any part of the property of the corporation and to sell, pledge or otherwise 1 2 dispose of such bonds or other obligations of the corporation for its corporate 3 purposes. To purchase, hold, sell, transfer shares of its own capital stock provided it shall not use its funds or property for the purchase of such shares when such use would cause any impairment of its capital stock.
