ARTICLES OF INCORPORATION OF PRO-1 AUTOMOTIVE, INC.

FIRST: The name of this corporation is Pro-1 Automotive, Inc.

SECOND: The principal office and place of business in Idaho, 45714 TOAKO Registers is to be located at 4802 Chinden, Garden City, Nevada. Leasy Holles

THIRD: The nature of the business of said corporation shall be to engage in any lawful activity and to do anything as fully and to the same extent as natural persons might or could do, and in any part of the world.

FOURTH: This corporation is authorized to issue 8,000, shares of 1.00 par value common stock without further authorization from the Board of Directors; the Board of Directors of this corporation shall be authorized to issue more than one class of stock or more than one series of any class, including preferred or special stock, at any time.

The amount of capital with which this corporation will commence business is \$8,000.00

FIFTH: The members of the governing board shall be styled Directors and the First Board of Directors shall consist of three directors, as follows:

With the consent in writing, and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding, the Directors shall have authority to dispose, in any manner, of the whole property of this corporation.
