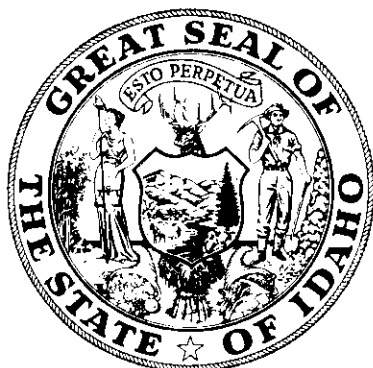

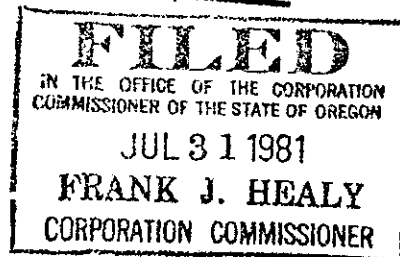

ARTICLES OF INCORPORATION
OF

The undersigned, a natural person of the age of eighteen years or more, acting as incorporator under the Oregon Professional Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME.

The name of the corporation is HANSON, DUNAHUGH, VAIVODA, THOMPSON, NICHOLSON, ARCHITECTS, A.I.A., P.C.

ARTICLE II. DURATION.

The period of duration of the corporation shall be perpetual.

ARTICLE III. PURPOSES.


