The undersigned, president and secretary of the Grangeville Country Club, Inc., hereby certify that at a general membership meeting of the stockholders of said corporation, duly called and held at Grangeville, County and State of Idaho, on the 25th day of January, 1986, pursuant to a resolution adopted by a meeting of the Board of Directors on the 14th day of January, 1986. That at such membership meeting, more than two-thirds (2/3) interest of members were present in person or represented by proxy and voted in favor of the amendments and changes hereinafter set forth, and every one of them, including the amendments and changes of the Articles of Incorporation as hereinafter set forth to read as follows:

ARTICLE V.

There shall be not less than five nor more than eleven directors of this corporation, the exact number to be determined by the by-laws. A director must be a member of the corporation. The Board of Directors shall be vested with the management of the business and affairs of the corporation

Resolve, further, that the officers of this corporation be and they are hereby authorized to take necessary steps to make this amendment effective.
