WHEREAS, the financial condition of RECREATION, INC. is such that a reduction in the number of authorized shares of capital stock will not reduce the fair value of the assets of the corporation to an amount less than the total amount of its debts and liability plus the amount of its capital stock so authorized, and

WHEREAS, the total number of shares previously authorized was One Million (1,000,000) shares each having a par value of One Dollar (\$1.00) and there being no shares authorized without par value, now, therefore,

BE IT RESOLVED that Article V of the Articles of Incorporation be amended to reduce the capital stock of said corporation from One Million (1,000,000) shares of common stock with a par value of One Dollar (\$1.00) per share to Two Hundred Thousand (200,000) shares of common stock with a par value of One (\$1.00) Dollar per share.
