KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a CORPORATION, under the Laws of the STATE OF IDAHO.

AND WE CERTIFY,

FIRST.- That the name of said Corporation is the WEISER MERCANTILE CO., LTD.

SECOND.- That the purposes for which it is formed are: To conduct a general wholesale and retail mercantile business and all lines of business usually carried on in connection therewith, at Weiser City, Washington County, State of Idaho and at such other place or places in the State of Idaho as may be selected; to buy, sell and barter goods, wares and merchandise, personal property, commodities, produce and agricultural products; to borrow and loan money; to execute, indorse, negotiate, assign, discount, issue, buy, take, receive and collect bills, bonds, promissory notes, mortgages and other securities and evidences of indebtedness; to acquire and dispose of, let, lease, rent and hire real estate; and generally to do, transact and perform every act and thing and to execute and deliver every instrument or writing, under seal or otherwise, and to demand and receive, enforce, compromise, collect, assign and discharge every evidence of indebtedness pertaining to, or connected with or growing out of said business.

THIRD.- That the place where its principal business is to be transacted shall be Weiser City, Washington County, Idaho.

FOURTH.- That the Term for which it is to exist is TWENTY-FIVE YEARS, from and after the date of its incorporation.
