ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

WESTERN PSYCHIATRICS ASSOCIATES, CHARTERED

The undersigned, being the Incorporator of Western Psychiatrics Associates, Chartered, a corporation organized under the Idaho Business Corporation Act and the Idaho Professional Service Corporation Act, hereby adopts the following Articles of Amendment to the Articles of Incorporation for the Corporation, pursuant to Sections 30-1-59, 30-1-61 and 30-1312, Idaho Code.

ARTICLE 1

ARTICLE 2

The Amendments adopted are as follows:
