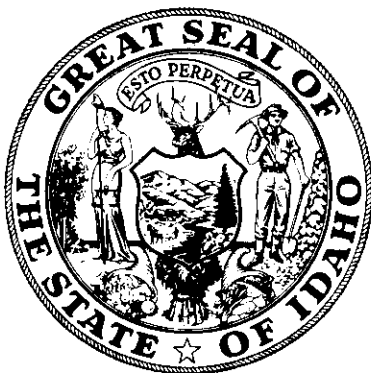

ARTICLES OF INCORPORATION  
of the  
IDAHO CHAPTER OF the CLINICAL LABORATORY MANAGEMENT ASSOCIATION, INC.

We, the undersigned natural persons of the age of twenty-one years or more, adopt the following Article of Incorporation for this Chapter pursuant to the laws of the State of Idaho.

FIRST: The name of the organization is the IDAHO CHAPTER OF THE CLINICAL LABORATORY MANAGEMENT ASSOCIATION, INC.

SECOND: The duration is perpetual.

THIRD: The purposes for which the Chapter is organized are as follows:

(a) To encourage cooperation and exchange of information among those engaged in management of clinical laboratories; to upgrade managerial and administrative skills in clinical laboratories; to improve the professional competence of its members by holding conferences, workshops and seminars; to publish educational periodicals; to encourage, promote and maintain high standards of management in clinical laboratories;

(b) To carry on any other business in connection therewith not contrary to the laws of the State of Idaho and with all the powers conferred upon non-profit organizations by the laws of the State of Idaho, and the Said Chapter is formed upon the articles, conditions and provisions herein expressed, and subject in all particulars to the limitations relating to non-profit organizations which are contained in the laws of the State of Idaho.

(c) No part of the net earnings of the Chapter shall be used to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the Chapter shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Chapter shall be to influence legislation, and the Chapter shall not participate in, or intervene in (including publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

FOURTH: There shall be members of the Chapter who shall be accepted in accordance with the terms of the by-laws.

FIFTH: The initial address of the Chapter shall be c/o St. Alphonsus Regional Medical Center Laboratory, 1055 N. Curtis Rd., Boise, Idaho 83706.

SIXTH: The initial registered agent of the IDAHO CHAPTER OF THE CLINICAL LABORATORY MANAGEMENT ASSOCIATION, INC. shall be the Secretary/Treasurer, Stephen Nesbitt, c/o St. Alphonsus Regional Medical Center Laboratory, 1055 N. Curtis Rd., Boise, Idaho 83706.

SEVENTH: Directors shall be elected in accordance with the terms of the by-laws.

EIGHTH: Upon the dissolution of the Chapter, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of the Chapter, transfer all remaining assets to the Clinical Laboratory Management Association, Inc.
