ARTICLES OF INCORPORATION

The undersigned, acting as incorporators under the Idaho Non-profit Corporation Act, hereby adopt these Articles of Incorporation:

**ARTICLE ONE: Name**

The name of the corporation shall be CANCER AND COMMUNITY CHARITIES, INC. (hereinafter: "The 3C's").

**ARTICLE TWO: Purpose**

The 3C's is organized exclusively for charitable and educational purposes, including in such purposes the receipt of contributions and the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code. The 3C's offers opportunities to all residents of Coeur d'Alene, but especially newcomers to the area, to become better acquainted with the community and its people, inspiring them to join others who are interested in raising funds through charitable activities to meet needs at the local level.

**ARTICLE THREE: Members**

Members shall be anyone in the Coeur d'Alene area who is interested in meeting new people, in expanding personal interests and skills, and assisting in the charitable work of The 3C's. Members whose dues are currently paid have the right to vote for officers and directors of The 3C's.

**ARTICLE FOUR: Limitation of Actions**

No part of the funds of The 3C's shall inure to the benefit of, nor be distributed to, its officers or directors. The 3C's shall be authorized and empowered to make payments in furtherance of the purposes set forth in Article Two hereof. No part of the activities of The Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the 3C's shall not participate in any political campaign of any candidate for public office.

Notwithstanding any other provision of these Articles, The 3C's shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under the provisions of Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE FIVE: Duration**

The duration of The 3C's shall be perpetual. Upon the winding up and dissolution of The 3C's, the Board of Directors shall, after paying or making provisions for paying all of the debts and obligations of The 3C's, distribute the remaining assets of the corporation to a non-profit fund, foundation, or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE SIX: Registered Office and Agent**
