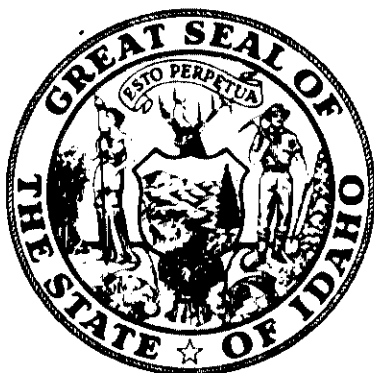

ARTICLES OF INCORPORATION
OF

THE GEM COMMUNITY CHURCH PROPERTIES, INCORPORATED

I. NAME

28 SEP 29 17 9 04

THE NAME OF THIS CORPORATION SHALL BE THE GEM COMMUNITY CHURCH PROPERTIES, INCORPORATED.

II. PURPOSE

THE PURPOSE OF THIS CORPORATION IS TO ENABLE A GROUP OR SOCIETY OF CHRISTIAN BELIEVERS TO CONDUCT BUSINESS AND TO OWN AND TO HAVE LEGAL TITLE TO REAL PROPERTY, WHICH IS TO BE USED FOR CHURCH MEETINGS AND OTHER PHASES OF THE LORD'S WORK, UNDER THE PROVISIONS AND THE STATUTES OF THE STATE OF IDAHO. THE PURPOSE HEREIN RECITED SHALL BE CONSTRUED SPECIFICALLY AND LIMITED TO THE RECITAL HEREIN CONTAINED. THE CORPORATION SHALL NOT BE CONSTRUED AS BEING A PART OF THE CHURCH MEMBERSHIP ITSELF NOR SHALL IT HAVE JURISDICTION WHATSOEVER OVER THE CONDUCT OF THE CHURCH MEETINGS THAT MAY BE HELD IN THE CHURCH BUILDING LOCATED UPON THE PROPERTY TO WHICH THE CORPORATION HAS LEGAL TITLE AND THE GEM COMMUNITY CHURCH SHALL BE CONSIDERED ONLY AS TENANTS OF THE PROPERTY SO OWNED BY THE CORPORATION.

III. DURATION

THIS CORPORATION SHALL BE IN PERPETUAL EXISTENCE.

V. MEMBERS

A MEMBER OF THIS CORPORATION IS DEFINED AS ANY ELDER OF THE GEM COMMUNITY CHURCH OF EMMETT, IDAHO.

VI. DIRECTORS AND OFFICERS

THE BOARD OF DIRECTORS OF THIS CORPORATION SHALL BE ELECTED BY THE MEMBERS OF THE CORPORATION IMMEDIATELY AFTER THE ANNUAL BUSINESS MEETING OF THE GEM COMMUNITY CHURCH. IN TURN, THE BOARD OF DIRECTORS OF THE CORPORATION SHALL ELECT ITS OWN PRESIDENT, VICE-PRESIDENT, SECRETARY, AND TREASURER OF THE CORPORATION FROM WITHIN THE BOARD ITSELF.

VII. REVENUE

THIS CORPORATION IS A NONPROFIT CORPORATION. THIS CORPORATION SHALL NOT TRANSACT ANY BUSINESS FOR THE PERSONAL GAIN OF ANY MEMBER OR DIRECTOR OR OFFICER. HOWEVER, IT MAY RECEIVE GIFTS IN ANY FORM TO BE CREDITED TO ITS ACCOUNT TO BE USED FOR ANY PURPOSES SET FORTH IN THE GEM COMMUNITY CHURCH CONSTITUTION AND BY-LAWS OR IN THESE ARTICLES OF INCORPORATION.

VIII. TITLE

NO MEMBER OR DIRECTOR OF THIS CORPORATION SHALL HAVE ANY PERSONAL RIGHT OR TITLE TO ANY PROPERTY HELD BY THE CORPORATION, EXCEPT SUCH RIGHT OR TITLE AS MAY BE CLAIMED BY THE TERMS OF ANY MORTGAGE WHICH THE CORPORATION MAY CONSUMMATE WITH A MEMBER.

IX. AMENDMENTS

THE BY-LAWS OF THIS CORPORATION MAY BE AMENDED BY THE BOARD OF DIRECTORS OF THE CORPORATION AT ANY OF ITS REGULAR BUSINESS MEETINGS.

X. DISSOLUTION

THIS CORPORATION MAY BE DISSOLVED AT ANY TIME, PROVIDED THAT SUCH DISSOLUTION BE DONE IN ACCORDANCE WITH THE CORPORATE LAWS OF THE STATE OF IDAHO. IF, FOR ANY REASON, THIS CORPORATION IS DISSOLVED, ALL PROPERTY AND OTHER ASSETS OF THE CORPORATION SHALL BE USED IN SOME OTHER PHASE OF THE LORD'S WORK AS SELECTED AND DISPERSED BY THE BOARD OF DIRECTORS OF THE CORPORATION.
